6, 12 or 24 Month Optional Service Agreement

If **You** selected a 6, 12 or 24 month Optional Service Agreement (OSA) and **You** have paid **Us** the OSA charge, **We** agree with **You** as follows:

All terms and conditions stated in the LKQ Heavy Truck Parts Replacement Promise attached to **Your** original invoice apply to this OSA, subject to the following additional terms and conditions:

- For 6, 12 or 24 month coverage, this OSA begins on the date of Your original invoice and shall end 6, 12 or 24 months after Your original invoice date and covers the repair or replacement of the part of Assembly described on Your original invoice.
- 2. We have no obligations to anyone except to the customer named on the original invoice. This OSA is (a) non-transferable, and (b) non-refundable after the part or **Assembly** has been installed in a vehicle.
- 3. This OSA covers labor only to the extent described below in the definition of **Labor**.
- 4. For this OSA to be valid, Your original paid invoice must indicate (a) the coverage period of 6, 12, or 24 months, and (b) the accurate odometer mileage of Your vehicle as of the date of the invoice.
- 5. Mileage is limited as follows during the applicable OSA period:
 - If **You** purchased <u>6 months</u> of OSA coverage, the OSA will terminate on the earlier of 6 months after the date of **Your** original invoice or 50,000 additional miles on **Your** vehicle's odometer.
 - If **You** purchased <u>12 months</u> of OSA coverage, the OSA will terminate on the earlier of 12 months after the date of **Your** original invoice or 100,000 additional miles on **Your** vehicle's odometer.
 - If You purchased <u>24 months</u> of OSA coverage, the OSA will terminate on the earlier of 24 months after the date of Your original invoice or 200,000 additional miles on Your vehicle's odometer.

We have no obligations to provide OSA coverage if the mileage limitations described above are exceed.

In addition, **Donor Vehicles** with odometer readings that *exceed* the following mileages are not eligible for an OSA without the prior written approval of an **LKQ** Plant Manager:

- Small bore engine (less than 9 liters): 250,000 miles
- Large bore engine (greater than or equal to 9 liters): 700,000 miles

<u>KEY TERMS</u> (when used, Key Terms will appear in dark print) **"You**" and **"Your**" mean the Owner/**Repairer**/Parts Re-Seller (Customer) named on **Your** original **LKQ** invoice.

"We," "Us," "LKQ" and "Our" mean LKQ Corporation or its subsidiaries, 500 W. Madison Street, Suite. 2800, Chicago, Illinois 60661.

"Assembly" applies to an engine (including only the cylinder block, crankshaft, cylinder heads and all internal lubricated parts) and/or the transmission (including only the case, torque converter and all internal lubricated parts) and/or carrier assembly (including gear set, case with non-removable sub axles and flanges) purchased by **You** for installation in a vehicle.

"Breakdown" means the failure of the part or Assembly described on Your original invoice due to a manufacturer defect.

"**Repairer**" means an independently owned and operated Licensed Repair Facility in the United States or Canada.

"**Donor Vehicle**" means the heavy truck having a commercial truck classification rating of Class 4 or greater (excluding Classes 1, 2 and 3) from which **LKQ** removed the part or **Assembly**.

"Labor" means LKQ will reimburse the **Repairer** for the repair of a part or **Assembly** covered by this OSA up to 25% of the part or **Assembly** price as indicated on **Your** original invoice, provided that **You** provide **Us** with an estimate from the **Repairer**, provide proof of all scheduled maintenance, **We** approve of such repair, and **You** provide proof that the repair was completed by the **Repairer**.

At Our discretion, replacement parts used in covered repairs may include remanufactured, new, used or non-original equipment manufactured/aftermarket parts that meet Our quality standards. Replacement part or Assembly mileage may be equal to or greater than that of the original part or Assembly purchased from Us.

WHAT THIS OSA DOES NOT COVER

The LKQ Heavy Truck Parts Replacement Promise attached to Your original invoice contains important terms, conditions, limitations and exclusions that apply to this OSA. This OSA will immediately terminate upon the occurrence of any of the events described on The LKQ Heavy Truck Parts Replacement Promise under the caption "<u>All Warranties are Null and Void if</u>."

All **Breakdowns** must be promptly reported by **You** to the **LKQ** facility listed on **Your** original invoice or by calling the following toll free number: 877-557-8782.
